**CONSENT FOR CASUAL PLACEMENT OF A SKIP BIN / BUILDING WASTE CONTAINER  
IN A PUBLIC ROAD RESERVE - Section 68 Approval (Local Government Act 1993)**

Council herewith grants (Applicant/Owner Name).....  
 consent to stand a Skip Bin / Building Waste Container in the public road reserve – on a casual placement basis

This Section 139 Consent is granted subject to the following conditions: -

1. The container/skip bin shall bear the name, address and telephone number of the supplier. In each case, an after hours telephone number shall also be displayed.
2. The owner of the container/skip bin or the applicant for the permit shall attach a certified copy of a current Public Liability and Property Damage Insurance Cover of a minimum of ten million dollars (\$10,000,000.00).
3. The size, shape and colour of all building waste containers placed on public streets, should be to the satisfaction of Council.
4. Each container/skip bin shall be provided with reflectors to the satisfaction of Council.
5. Council reserves the right to remove or order the removal of any container/skip bin (if not behind a hoarding) despite any approval granted, if such container or the activity associated with it causes a nuisance.
6. The applicant shall be responsible for the removal of any waste deposited in or around the container/skip bin whether by himself, at his direction, or by any other person.
7. The applicant is responsible for any damage done to the road, kerb or footpath or to any landscaping in the road, due to the placement of the container/skip bin.
8. The applicant shall make good any damage caused to the property of any person or any property of Council by reason of the carrying out of any work by the Applicant under the Conditions of this Consent.
9. The Applicant shall, at all times, keep indemnified Council from and against all actions, suits, proceedings, losses, costs, damages, changes, claims and demands in any way arising out of or by reason of anything done or omitted to be done by the Applicant, in respect of the work in question.
10. The Applicant, at all times for the duration of this Consent, will not interrupt or otherwise disturb the traffic flow on the road, without first obtaining the consent of Council.
11. Should the Applicant fail to comply with any of these conditions or any requirement of Council as provided, then this Consent shall permanently lapse and the container/skip bin shall be removed by the Applicant, or by Council if deemed necessary (with associated costs) and any part of the work remaining within the road at that time shall be deemed to be an obstruction or encroachment under Section 107 of the *Roads Act 1993*.
12. This Consent must be held on the job and produced to any officer of Council when called upon.
13. The Applicant shall accept all responsibility for public safety during the construction of the works.
